# Parent and Child Programs

NSCR programs enhance child care and quality of life for North Shore children and their families.

## **Child Care Resource and Referral**

NSCR hosts the regional Child Care Resource and Referral (CCRR) Coordinator and is home to the North



Shore CCRR program. The local CCRR recruits and trains qualified child care providers, assists parents with referrals to child care and child care subsidies, provides information/resources via our newsletter, workshops and our library (open

to the public), hosts drop-in programs (Mother Goose, Circle of Care) and consults with community partners.

#### **Municipal Child Care Consultant**

The Municipal Child Care Consultant supports group child care as a resource expert for child care managers, provides information on the development of child care spaces, hosts group child care administrator meetings and helps plan the annual North Shore Early Childhood Conference.



# **Community Action Program**

NSCR is the coordinating agency for the North Shore Community Action Program for Children (CAPC) coalition, which develops programs that promote the healthy development of young children ages 0–6 and families facing challenging life circumstances.

# **Connect for Kids Planning Tables**

NSCR is the host agency for Connect for Kids, the umbrella for the Early Years and Middle Childhood Matters Planning Tables, with membership from agencies across the North Shore. The Tables provide coordination, planning support and community awareness for the distribution of programs and services to meet the needs of families and their children 0–12.

## **Wheels**

The Wheels mobile support program connects families to community resources and services via outreach to programs, events, parks and child care centres across the North Shore.





# **Seniors Programs**

North Shore Community Resources delivers three programs that enhance the health and well-being of seniors.

## **Caregiver Support Program**

The Caregiver Support Program assists people who are caring for an adult friend or family member by providing supportive networks, activities and workshops for caregivers.

#### **IMPACT**

# **Seniors One Stop**

Seniors One Stop (SOS) has been providing information,

resources, and referral services for seniors' programs since 1992.

This program produces the annual Seniors Directory for the North Shore, a vital resource used by people and professionals.



#### **IMPACT**

- 5,541 SOS program contacts
- 16 events/presentations to 537 participants

In a random survey of SOS users, 87% expressed satisfaction with information received and 89% felt accessing SOS made them feel more secure and independent.

#### **INSPIRATION**

- "Prompt, kind service. Felt good to be listened to, [the] SOS volunteer was a good listener."
- "They better not cut this service [SOS]."

## **Better at Home**

North Shore Better at Home supports seniors' independence by providing them with basic nonmedical services to help them remain in their homes.

#### **IMPACT**

- 147 clients with 1,177 service visits
- 145% increase in clients over prior year
- **349**% increase in service visits

# Information North Shore

NSCR is the best source for information and referral about services, resources and agencies on the North Shore. NSCR produces the **Green Book**, with more



than 30 categories and over 600 community resources listed, a rich resource that is the essential guide to services on the North Shore. Call, email, drop-in or visit nscr.bc.ca for information and referral assistance.

#### The North Shore Inter-Agency

**Network** is a non-partisan planning table comprised of social service and public sector organizations that deliver services to North Shore residents. The network provides a forum to discuss improvements to North Shore community services, identify emerging needs, and reduce program duplication.

NSCR's **Housing North Shore** assists people looking for affordable, accessible and appropriate housing. The **Community Housing Action Committee** provides a forum for citizens and organizations to work together to advocate for affordable housing on the North Shore.

#### **INSPIRATION**



# **Volunteer North Shore**

Through **Volunteer North Shore**, NSCR helps connect people wishing to volunteer with organizations needing volunteer assistance. We also promote volunteering as an important civic engagement contribution to creating a healthy, connected community. Volunteer North Shore has operated as the volunteer centre for the North Shore since 1976.

The **Community Volunteer Income Tax Program** offers income tax preparation assistance to low-income seniors and people with disabilities.

Volunteer North Shore produces the annual **North Shore Youth Volunteer Directory** (on-line and print versions), a key resource for youth to find volunteer opportunities on the North Shore.



The **Community Volunteer Spirit Awards** recognize six individuals or groups annually who embody the essence of giving back to their community.

# Legal Services

NSCR assists North Shore residents with legal problems through our Legal Advocacy program and our Legal Information and Assistance program. For clients who have limited income and whose legal problem will impact their financial well-being, our Legal Advocates assist with housing, employment, benefits, income security, debt, and related issues. Our Legal Information and Assistance program also offers basic information regarding other legal issues including family law. We provide educational workshops about the law to the public on various topics.
